CHURCH COUNCIL HIGHLIGHTS FOR 2013

February– The flooring contractor will be Midwest Custom Coatings. March 24, 2013, will be the last day of Sunday School so the floor project can be started. The Transition Team has been meeting and moving ahead on the Site Profile. A congregational group discussion will be held on Sunday, February 17, 2013, after church.

March- Due to the flooring project, Carolyn will be moving to Saunders' office after March 27th. Pastor Greg is ready to move to the parsonage at any time. Cindi Krause was present to discuss proceeds from WELCA fund raisers. They have \$8000. Some things that were discussed were: Painting parts of the church and replacing ceiling tile in the Fellowship Hall. \$275 was given toward the Confirmation Banquet, which will be held at the CCOC this year due to flooring project. \$1000 was allocated for a new water cooler in the hallway. An anonymous member also gave \$1000. \$4425 was given to the General Fund of Our Saviors. They are asking the Project Fund to contribute \$2300 in matching funds for the projects of painting, replacing ceiling tile, and the new water cooler.

April– Removal of flooring is going well. The Library will be moved to the lounge. Mark Peterson will make some shelving for that.

May–May 5, 2013 – Confirmation of four 9th graders. Our contract is up for the office copier, and it was decided to lease a new copier, which actually will be less than the monthly charge for our old copier. Ad will be put in the church bulletin to ask for seven adult and one youth volunteer for the Call Committee.

June– Joint Vacation Bible School with Cross of Calvary will be held this year at Our Savior's. Flooring project is now complete. Church directory pictures will be taken by LifeTouch June 12 – 15, 2013.

July– Ice Cream Social proceeds given to Millie Larson. Call Committee members are Barbara Marks, Lisa Lund, Shannon Hansen, Jill Rude, Jamie Bohlin, Les Plumley and Allison Krause.

August- Ten new members were received on Sunday, August 18.

September– A letter of resignation was presented by Pastor Greg. He has been offered an interim pastor position for a congregation closer to his home. September 29 was Pastor Greg's last Sunday at Our Savior's.

October– Pastor Bob Lehner, our new interim pastor, arrived on October 2. He will be working 92% of full-time and paid accordingly. Beverly Lentz Estate Bequest, we received a check for \$62,683.51. Will also receive \$5,462.05 each year.

December– The Call Committee researched and compiled an OSLC FMLA policy. Beverly Lentz Estate Bequest will be divided per the OSLC Bequest Policy. 80% will be disbursed to the Endowment Fund with proceeds yearly going to the OSLC Building Fund. 10% will be disbursed directly into the OSLC Building Fund, 5% will be given to the church at large, and 5% to the community at large.

In 2013 we borrowed on our line of credit most of the year. As the year ended the congregation came through and we ended the year in the black. A very big thank you to everyone who made this possible. As always our stewardship projects (Fair Stand, Turkey Supper, Friendship Supper, Quilting and Ice Cream Social are just a few examples) have been great successes. None of it would happen without the great volunteers we have at our church. Thank you for your time and commitment to our church. We look forward to another great year at Our Savior's.

BOARD OF PROPERTY AND PLANNING

The board of education and youth in 2013 consisted of Tim Buboltz, Shannon Hansen, Jason Krumheuer, Barb Marks, Cindi Krause, Jamie Bohlin, Karletta Marwede, Pastor Greg Hall / Pastor Bob Lehner and Jayme Ryan.

This year has once again been a busy and active one!! Thank you to everyone who helps with, donates to, and prays for our Youth Program here at Our Savior's. Here is a sampling of what happens during the year:

January – SPAM (Saturday Pizza and A Movie) was held, as well as an acolyte training was done for all 6th -9th graders.

February – Another SPAM was held. The Souper Bowl of caring was held on Super Bowl Sunday and the offerings went to the ELCA Malaria Campaign. Also starting Ash Wednesday and continuing through Lent the 7th – 12th grade families served suppers before worship and the confirmation students met with their mentors. In February OSLC hosted a SWMN Synod Leadership training with the Synod LYO board.

March –We wrapped up after school programing and Sunday School due to the flooring project. Confirmation was still held during the project but it was located at the CCOC (Christian Community Outreach Center). The Annual Palm Sunday Breakfast was served by the 7th- 12th grade families and the Board of Education and Youth. Vacation Bible School planning was started and it was decided that we would pair up with Cross of Calvary for this year's VBS. We also pair up with C of C for other youth programs through the year such as CLOCK (Christians Living Out Christ's Kindness a 10th -12th grade youth group), and FUEL (a youth lead worship service held 4 times a year for 8th – 12th graders).

April - Final interviews were held with Confirmation students

May- Due to the flooring project the Confirmation Banquet was held at the CCOC and served by The Master's Coffee Shop. Pictures and worship practice were also held on Wednesday just prior to the banquet this year due to sporting events on Saturday morning. This worked out great and will become a new tradition. On the first Sunday in May OSLC Confirmed four amazing 9th graders. The hanging basket sale was also held and delivered in May.

June – A Graduation recognition service was held on the first Sunday. Another set of ducklings have left our nest here at OSLC, all with strong faith wings ready to fly. Our Youth Program served a pancake breakfast at our fair stand during Island Days. In June we also started moving back into the church after our beautiful new floors were completed.

July- Lots of preparations happened to get ready for VBS.

August – Kingdom Rock VBS was held in conjunction with Cross of Calvary. We had over 100 kids in attendance and 45 people helping. It was a GREAT experience and we look forward to joining again in 2014.

September – Rally Sunday theme this year was "God's Work, Our Hands" and we focused on celebrating the 25th Anniversary of the ELCA and what God calls us to do. We also held a potluck dinner that day. Our Confirmation classes began in September. The Our Savior's Youth Annual Golf Scramble was held and it was another fun and successful day. Our Confirmation classes attended 30 Hour Famine event organized by five area congregations at BOLD school at the end of September. During the event the young people learned about hunger, clean water, poverty and filled over 9000 food bags for Kids Against Hunger. OSLC helped start a new program at the CCOC for High School Students called Hang Time. Its held on Monday from 6:00-7:30, a light supper is served by rotating congregation's in the school district, there is also time for homework, hanging out and a short devotion.

October - The Wednesday After School Programs started back up by making apple crisps and cards for the Pastor to take to our shut ins, it was a fun learning and sharing experience. Planning also started for the 2015 ELCA National Youth Gathering in Detroit. Michigan.

November – The DTC (Detroit Christian Travelers, 2015 National Gathering group) made and sold lefse. It was a fun way to spend a Sunday afternoon learning, laughing and flipping lefse. Twelve of our $7^{th} - 9^{th}$ graders and 3 chaperones attended the SWMN Synod Jr High Gathering. It was another wonderful experience with an amazing band and wonderful speakers.

December – We ended the year with a wonderful Sunday School Christmas Program and potluck to celebrate Jesus' Birth.

2013 Sunday School Annual Report

Sunday School started out the year the same as the previous year as far as the curriculum that was used. The children gather in the sanctuary for opening with the pastor or Jayme. This is followed by music (Nursery-2nd, 3rd – 9th). Then the children do memory work and a lesson overview with their teacher. At this point, a rotation leader joins them to explore the lesson thru craft, video, science, snack, or craft project. The January lesson focused on baptism and how it marks our entry into God's kingdom. Ordinary water combined with God's word frees us from sin and death for a new, eternal life. February lessons centered around Holy Communion and learning that when we share in Jesus' body and blood, we share in his life. March marked the end of Sunday School until fall due to the flooring project.

Rally Sunday on September 8th brought us back together again. The theme was "God's Work, Our Hands." We celebrated with a potluck after the worship service.

A couple of changes were implemented to reduce the workload of the director. There are no longer rotation leaders and the teachers in each of the classrooms decide the additional lessons to teach to their class. September and October lessons revolved around Jesus' miracles, the wedding at Cana and calming the stormy seas. In November the children began to Anticipate Advent and learn how to prepare for the glory and wonder of Jesus birth. The Christmas program, "The Brightest Star" was performed on December 15th during worship with a potluck (of course!) following. The offering that is collected each week is donated to a charity that the children help decide. The January – March offering was donated to Renville County Back the Pack.

The September – December offering will be donated to Ronald McDonald House. Pop tabs are also being collected form Ronald McDonald House.

There are currently 47 Sunday School children on roll. There are 7 teachers, 3 assistants, and 2 music teachers who graciously teach our children each week.

Annual Report - Bp. Jon Anderson - 2014 - Formation

After this the Lord appointed seventy others and sent them on ahead of him in pairs to every town and place where he himself intended to go. He said to them, 'The harvest is plentiful, but the laborers are few; therefore ask the Lord of the harvest to send out laborers into his harvest. Go on your way. See, I am sending you out like lambs into the midst of wolves. Carry no purse, no bag, no sandals; and greet no one on the road. Whatever house you enter, first say, "Peace to this house!" ... whenever you enter a town and its people welcome you, eat what is set before you; cure the sick who are there, and say to them, "The kingdom of God has come near to you."

Luke 10 - NRSV

As a synod we continue to focus on the word, "formation." We continue to note and celebrate all the ways we can see that God has been forming us as the baptized, as congregations and as a synod. I invite you to focus on what God is up to



in you, in your family, in your community of faith and in God's world. We know that the most important work of the Spirit is often hidden. We know it is easy to make mistakes as we seek to understand the presence and work of God in our lives. Yet we are confident that our Gracious God continues to call us, form us and send us to serve. So, we watch for signs of God's forming and reforming grace. We are grateful for God's many gifts.

God is not done forming us, forming you. God is not done with our church, we continue to be shaped and formed into the cross of Christ. God has a mission for

this synod. God is forming us so that we all share a conviction that "every baptized one is a minister, every pastor a mission director and every congregation a mission station."

The lesson from Luke 10 above has been a cornerstone text in many of our meetings this year as we ponder how God is

making us, and all things, new in Christ. Jesus continues to form us like he formed the early apostles and then sent them ahead of him. I invite you to go back and read the text. Notice that God forms them by sending them two by two. God gives us the gift of companions in Christ and the community of faith. God trusts the early disciples and sends us out into a world that is full of challenges and dangers. When we are tempted to protect ourselves and gather more things to do our ministry, Jesus teaches the disciples then, and teaches us now, to travel light trusting in God. Jesus commands us to proclaim the peace that only God can give that we know most deeply in Jesus



and his cross. This is our mission field and there is much to do as we seek to proclaim the peace of God to a troubled world, cure the sick, and proclaim the closeness of the reign/rule/kingdom of God in Christ Jesus.



God forms us for a mission that is both local and global. This year's assembly will be a Glocal Mission event. We will focus on the mission we are called to in our many vocations inside God's community and beyond the Church's walls in God's world in our neighborhood, state, country and around the world. We will have time to work on our theme, "Journey with Jesus: Do you know what has happened?" based on the Emmaus text from the end of Luke.

As you think about yourself, your congregation, your synod and churchwide expression it is important to remember that growth takes many forms in addition to numbers. We see signs of growth in people, leaders, congregations,

our governance and our engagement with the mission field God has placed us in. Join me in celebrating and affirming growth prompted by God's Holy Spirit.

We are seeing signs that people are listening to God in scripture and prayer, listening to one another and listening to our context as they work on sorting out how to do ministry and mission in this time and in our many contexts. We see signs that our leaders are zooming out to get perspective and then zooming in as they make very specific plans. They are assessing how the environment is changing. Instead of getting lost in anxiety or lost in denial, we are seeing congregations plan, run experiments, evaluate and develop capacities they have not had before. This fall we had multiple events inviting people to think about how to engage in faith formation in this time and culture. We watched our leaders show up in significant numbers, learning, discussing, praying, discerning and then decided to try to new things trusting that our forming and reforming God would be with them. We are thankful for how they seek to be stewards of the Gospel in this time and our future. Our mission field is changing. We are not called to look back and turn into pillars of salt, but rather to follow God's pillar of cloud by day and fire by night through the wilderness of our time.



I wonder if we should get signs to put outside our synod office, congregation's buildings, our home and our institutions. If so the sign should say "Warning – God at Work." God is at work. God is calling us to faith, calling us into the community that bears Jesus name in our baptism, called from death to life, called to conversion of our heart, mind and pocketbook, called to new life, called deeper into this world not to climb some ladder of salvation, called to wider awareness of God's Church and called to greater awareness as we live in the world. God is at work calling us to new life.

Your synod continues to Boldly walk in Christ's Mission of....

Engaging Leaders –We are thankful for all the new leaders God has called to serve in our congregations in all kinds of ways. We give thanks for all the congregations and synods who prepared the rostered leaders who have come to serve in our mission field with us. We are thankful we have been called to be a hothouse for leaders in God's Church.

Equipping Congregations – We are thankful for all the ways God has been inspiring and encouraging congregations in their proclamation of God's grace, to receive the gifts of newcomers. We are particular thankful for the courageous redevelopment work happening in our new area parishes and congregations who have created alliances. It takes faith to trust God will lead you into new ways to be and do church. We see faithful and fruitful congregations trusting and following Christ into God's preferred and promised future.

Serving in God's World – We are formed to love and serve God and love our neighbors. That work takes place in our everyday life and many callings and beyond our communities. Road Trip! This is the theme for Green Lake Lutheran Ministries' upcoming summer season. Our focus will be on Jesus' road trip to Jerusalem. We'll be reminded that whenever and wherever we travel Jesus is with us on the journey.

I've always been up for the adventure of a road trip. Whether it's leading groups on trips, or in my own personal travels, I've taken my share of road trips across country. The ups and downs of life on the road have provided me with many special friends and memories. I have enjoyed the adventures and challenges of the road as well as the sweet homecomings.

This year at GLLM we have also enjoyed a journey. We continue to travel through a time of transition for the organization as well as for the church at large. We have experienced the ups and downs of the road, the adventures and the homecomings. This means that sometimes we find ourselves re-charting our course - in some places trying a different direction, in others returning to the well-known paths.

A new direction for us this summer will be the suspension of our day camp program. Much thought went into this decision. Due to the changing needs of congregations, the challenges of staffing day camp teams and the costs associated with day camp we are taking a "time-out" from day camp. We believe this will allow us to hone our focus on quality, on-site, programming to ensure the best possible experience for campers who join us at one of our three sites this summer. We value our congregations as travelling companions and will be looking at ways that we can continue to travel together in that are more effective for our many and varied ministry settings.

Day Camp used to be a "feeder" program for our on-site offerings, but we are finding that is not the case as much anymore, nor does day camp have the life-changing impact on kids' lives the way that our on-site programs do. Studies show that one of the most significant faith formation experiences a young person can have is to attend a bible camp. If you really want to make a difference in kids' lives bring them to camp!

Another new direction, (that really is a return to a familiar path) is that we are excited to be writing our own summer 2014 bible study curriculum for the first time in many years. Over the last several years we have purchased the summer camp curriculum from Lutheran Outdoor Ministries. This year we made the decision to write our own and allow for congregational leaders and pastors to have input in shaping what kids will be experiencing at camp. The stories chosen from the Gospel of Luke will reflect our baptismal journey of being called, claimed, changed from the inside out, and commissioned to go out as people of the way – Christ's way – of loving the world. On the road, new people, new places, and new challenges await us. We will make connections to baptism and our life in Christ throughout the week.

One more adventure on GLLM's journey this year was the search for a new Executive Director. The search committee worked faithfully for several months, but the search ended without a candidate being recommended. While the news about the search process may initially seem disappointing, the GLLM Board of Directors sees this as an important and necessary detour, an opportunity to ensure that GLLM remains a quality leader in outdoor ministries.

The GLLM Board has been evaluating what it has learned from the search process and will be engaging in several in-depth sessions about the mission and future vision of GLLM. An action plan and new time table for a renewed executive search will come out of these conversations. In the meantime, our committed and qualified staff are continuing to faithfully serve, moving forward in faith as this ministry has done now for 75 years.

As we continue to move through this time of transition, we thank you for all the ways you support this ministry and we ask for your continued support us as we go forward. Your prayers, financial support, volunteering, and encouragement is what has sustained and will continue to sustain this ministry long into the future.

Finally, at the end of a long road trip it is always good to arrive back home again. This past summer we enjoyed the homecoming of staff and camper alumni as we celebrated GLLM's 75th Anniversary. We hope that all who come through our sites will always feel a sense of coming home when they return and that when you leave you are refreshed for the journey that lies ahead. We go out trusting that God goes with us on the journey.
